There is also a panoramic Viewing Deck that opens up striking views of the border terrain, serving as a reminder of how close you truly are to the frontline.

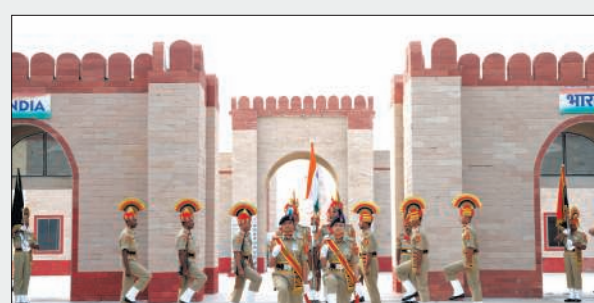
And the best part about the entire ex-

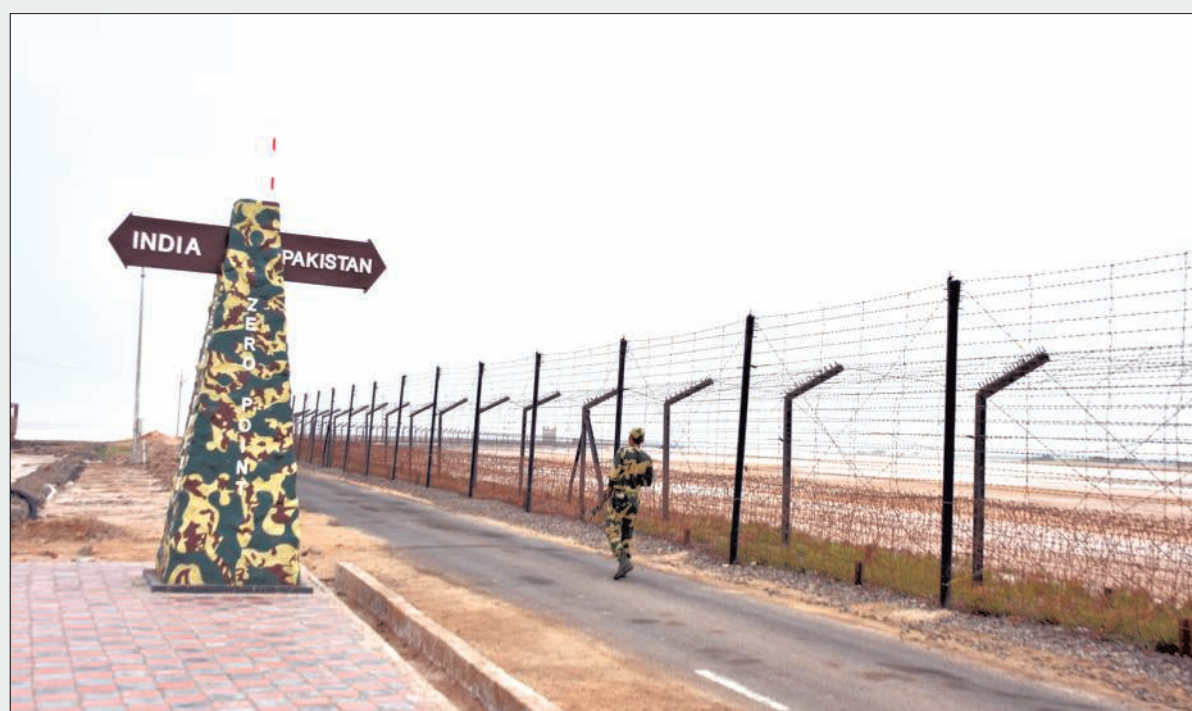
